Introduction and Purpose

Youth Start Limited uses cookies and similar technologies on our website to enhance user experience, analyse website usage, and deliver personalised content and advertising. This Cookies Policy explains what cookies are, why we use them, which cookies we use, and how you can manage your cookie preferences.

Cookies are small text files that are stored on your device (computer, tablet, or mobile phone) when you visit a website. Cookies allow websites to remember information about your visit, such as your preferences, login status, and browsing activity. Cookies are widely used on the internet and are essential to the functioning of many websites.

The use of cookies is governed by the Privacy and Electronic Communications Regulations 2003 (PECR) and the UK General Data Protection Regulation (UK GDPR). We are committed to using cookies transparently and in compliance with these regulations. We obtain your consent before storing non-essential cookies on your device.

This policy applies to all visitors to our website (youthstart.co.uk) and explains our cookie practices in detail.

Scope

This Cookies Policy applies to:

- All cookies and similar technologies used on the Youth Start website (youthstart.co.uk)
- All visitors to our website, including job applicants, employers, and members of the public
- All information collected through cookies and similar technologies

This policy does not apply to cookies used by third-party websites that you may visit from links on our website. Third-party websites have their own cookie policies, and we are not responsible for their cookie practices.

What Are Cookies?

Cookies are small text files that are stored on your device when you visit a website. Cookies contain information such as:

- A unique identifier for your device or browser
- Information about your preferences and settings
- Information about your browsing activity
- Login credentials and session information

Cookies are created by the website you are visiting (first-party cookies) or by third-party services used by the website (third-party cookies). Cookies can be either session cookies (which expire when you close your browser) or persistent cookies (which remain on your device for a specified period).

Similar technologies to cookies include web beacons (small invisible images embedded in web pages that track page views), pixels (similar to web beacons), and local storage (a technology similar to cookies that stores larger amounts of data on your device).

Why We Use Cookies

We use cookies for the following purposes:

Essential Cookies:

Essential cookies are necessary for the website to function properly. These cookies enable core functionality such as page navigation, access to secure areas of the website, and form submission. Without essential cookies, the website would not function correctly. Essential cookies do not require your consent under PECR.

Performance Cookies:

Performance cookies collect information about how visitors use our website, such as which pages are visited most frequently, how long visitors spend on each page, and whether visitors encounter errors. This information helps us understand how the website is being used and identify areas for improvement. Performance cookies do not identify you personally and are used only for analytics purposes.

Functional Cookies:

Functional cookies remember your preferences and settings, such as your language preference, font size, or accessibility settings. These cookies enhance your user experience by allowing the website to remember your choices when you return.

Marketing Cookies:

Marketing cookies are used to track your browsing activity across the internet and to deliver personalised advertising based on your interests. Marketing cookies may be used to show you advertisements for Youth Start services on other websites you visit. Marketing cookies require your consent before they are stored on your device.

Cookie Consent

Your consent preferences are stored in a consent cookie that remembers your choices when you return to the website.

Withdrawing Consent:

You can withdraw your consent to non-essential cookies at any time by visiting our cookie preferences page or by clearing your cookies and visiting the website again.

Consent for Children:

We do not knowingly collect information from children under the age of 13. If we become aware that a child under 13 has provided consent to cookies, we will delete the consent and any associated data.

Third-Party Cookies

We use third-party services that may set their own cookies on your device. Third-party cookies are subject to the privacy policies of the third-party providers. We have listed the main third-party cookies above (Google Analytics, Hotjar, Facebook Pixel, LinkedIn Insight Tag).

Legal Basis for Cookie Use

Our use of cookies is based on the following legal bases:

Consent (PECR):

We obtain your explicit consent before storing non-essential cookies on your device, as required by the Privacy and Electronic Communications Regulations 2003.

Legitimate Interests (UK GDPR):

We use essential cookies without consent because they are necessary for the website to function. We rely on legitimate interests to use performance and functional cookies where consent has not been obtained, as these cookies help us improve the website and provide a better user experience.

Contract (UK GDPR):

Where you have created an account on our website, we use session cookies to maintain your login status and enable you to access your account.

Your Rights

You have the following rights in relation to cookies and the data they collect:

Right to Withdraw Consent:

You can withdraw your consent to non-essential cookies at any time by visiting our cookie preferences page or by adjusting your browser settings.

Right of Access:

You have the right to request information about the cookies stored on your device and the data they collect. You can contact us at contact@youthstart.co.uk to request this information.

Right to Deletion:

You can delete cookies stored on your device at any time through your browser settings.

Right to Object:

You can object to the use of marketing cookies by withdrawing your consent or by using the opt-out mechanisms provided by third-party providers.

International Data Transfe

These transfers are protected by Standard Contractual Clauses (SCCs) or other appropriate safeguards in accordance with UK GDPR requirements.
