We work with employers to create employment opportunities and with young people to develop the skills and confidence needed to succeed in employment.

3. Use of the Website

Youth Start provides a 12-week mentorship programme to support young people during their employment. The mentorship programme includes:

- Regular one-to-one mentoring sessions
- Skills development and training
- Support with workplace challenges
- Career development and progression support

Mentorship is provided by Youth Start staff members and may in future be provided by trained volunteers or external mentors. The mentorship programme is designed to support young people to succeed in employment and to develop their skills and confidence.

5. User Responsibility

5.1 Account In
